Applicants who are offered and accept a unit must sign a tenancy agreement and may be required to sign tenancy agreement addendums that cover topics such as pets, parking, smoking, crime free housing, etc.

- Be a Member of Squamish Nation or those caring for minors who are members of Squamish Nation.

- Minimum income requirements are not met,
- The applicant is not prepared to assume the responsibilities and costs associated with regular home maintenance, or,
- The applicant knowingly provides false information.
