#### Other Important Information

Hiyám' ta Skwxwú7mesh Housing Society is gathering the applicant's information on all household members, including income and assets for those aged 19+, and will complete additional checks to assess a household's ability to uphold the obligations of a tenancy agreement. This includes reference checks and personal interviews.

Applicants will be contacted for more information, which will involve providing supporting documents, such as income verification.

Applicants who are offered and accept a unit must sign a tenancy agreement and are required to sign tenancy agreement addendums that cover topics such as pets, parking, smoking, crime free housing, etc.

### Who qualifies for Hiyám' Housing homes?

To qualify for a Hiyám' home at Senákw, the applicants' total household income must not exceed specified limits for each unit type:

- **Studio or one-bedroom** \$20,000-\$60,000
- **Two-bedroom** \$30,000-\$80,000
- **Three-bedroom** \$30,000-\$100,000

**Please note:** Parking at Senákw is very limited. Most units do not have a parking space available.

To be eligible an individual must:

- Be a Member of Squamish Nation (in good standing) or those caring for minors who are members of Squamish Nation,
- Your total household income from the previous calendar year must be below the income limit,
- Show that you have the financial ability to pay rent,
- Suitability of the housing unit size matches the needs of the family size.

Applications may be disqualified if:

- Application forms are incomplete,
- Income requirements are not met,
- The applicant is not prepared to assume the responsibilities and costs associated with regular home maintenance, or,
- The applicant knowingly provides false information (Need help? Contact us).

- Proof of income:

- Most recent Tax Return
- If you receive tax-free income, include relevant T-slips

Hiyám' Housing may follow up to confirm your information. You may be asked to provide:

- Bank statements
- NOA (Notice of Assessment)
- Additional tax documents

- that this application is not an agreement on the part of Hiyám Housing or its members to provide me/us with housing;
- that if I/we are being considered for an available unit, Hiyám Housing will gather additional information in order to assess my/our ability to uphold the obligations of a tenancy agreement and it is my/our responsibility to provide or cause to be provided information requested to assist with this assessment;
- that it is my/our responsibility to tell Hiyám Housing of any changes to the information given in this application and to provide any supporting materials required;
- that false information given by me/us may result in my/our application being cancelled from consideration;
- I agree that once I move in, the rental unit will be used as my primary residence.
